CMS Oral Health Initiative - Goals

- **Goal #1 – Increase by 10 percentage points the proportion of Medicaid and CHIP children (enrolled for at least 90 days) who receive a preventive dental service.**
 - Baseline year is FFY 2011
 - Goal year is FFY 2015
- **Goal #2 – Increase by 10 percentage points the proportion of Medicaid and CHIP children ages 6 to 9 (enrolled for at least 90 days) who receive a dental sealant on a permanent molar tooth.**
 - This goal will be phased in.

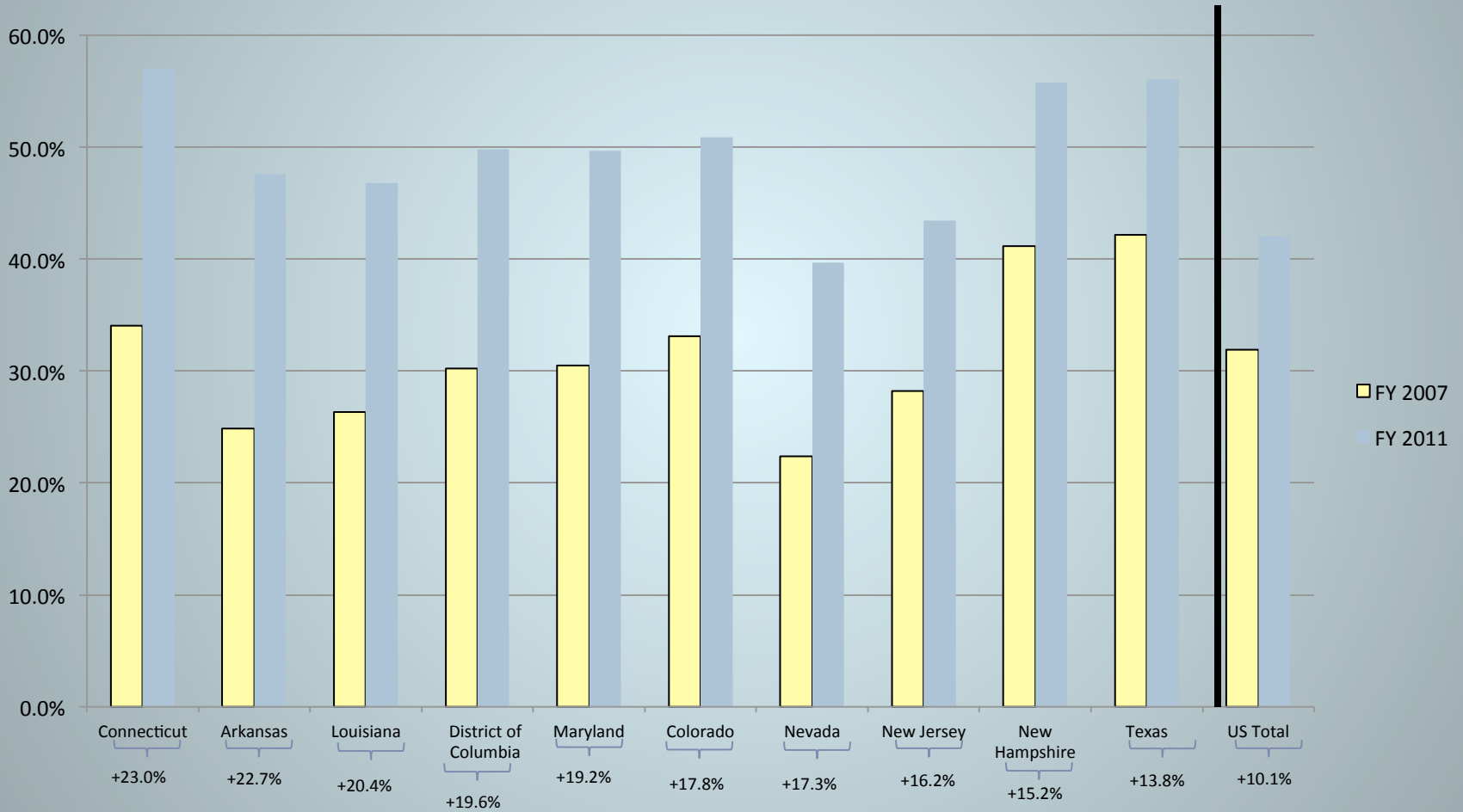
Measuring Progress: CMS-416

(some similar measures are in CARTS for separate CHIP programs)

**Total number of children (enrolled for at least 90 days) receiving:
(each line represents an unduplicated count of children)**

- **Line 12a – any dental service** (by or under the supervision of a dentist)
- **Line 12b – a preventive dental service**
- **Line 12c – a dental treatment service**
- **Line 12d – a sealant on a permanent molar tooth**
- **Line 12e – a dental diagnostic service**
- **Line 12f – an oral health service provided by a non-dentist**
(and not under the supervision of a dentist)
- **Line 12g – any dental or oral health service (12a+12f)**

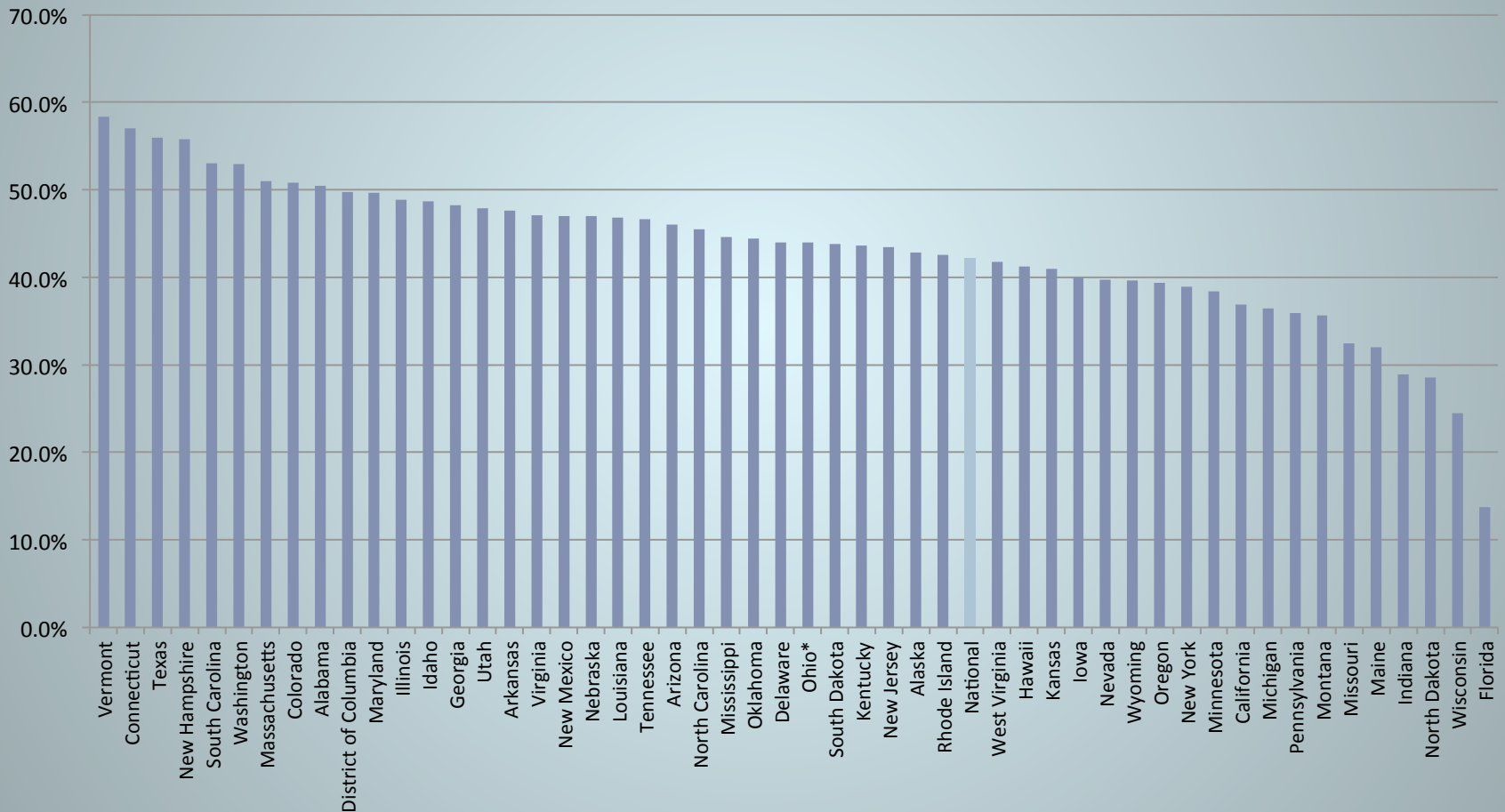

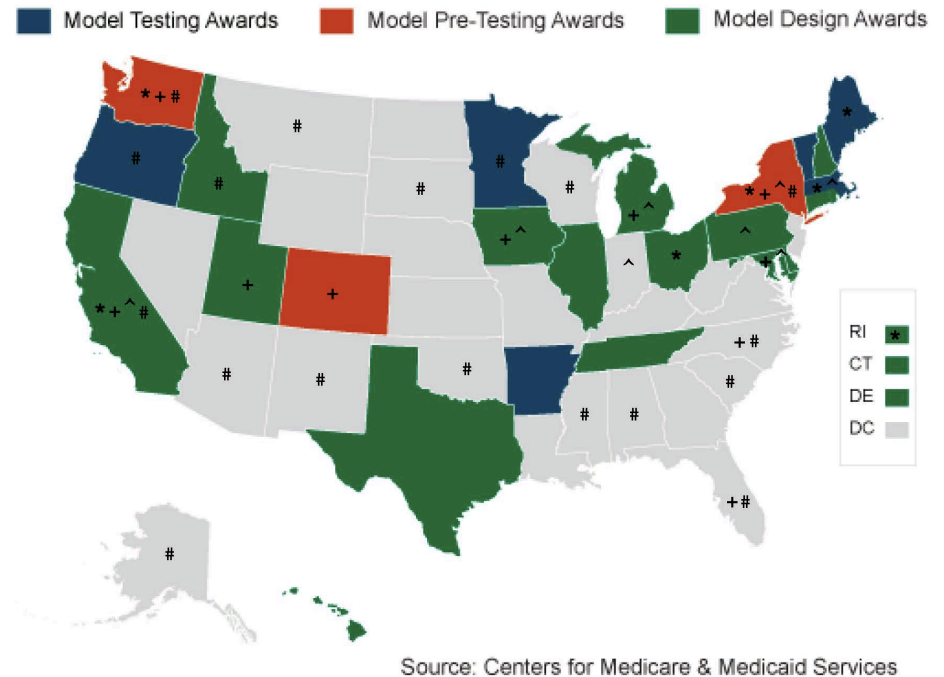

- **\$1B Innovation Challenge -**

to test new payment and service delivery models that will deliver better care and lower costs for Medicare, Medicaid and/or Children's Health Insurance Program (CHIP) enrollees.

- **State Innovation Model (SIM)**

Initiative - \$300 million to support the development and testing of state-based models for multi-payer payment and health care delivery system transformation
